

Limited Product Warranty

All warranty coverage is subject to the terms, conditions, limitations, remedies, and legal rights as set forth in the following. This warranty is extended only to the Customer/Property Owner and is not assignable or transferrable without the express written consent of ALLBONDSTM. (hereafter referred to as ALLBONDSTM)

PANEL WARRANTY

ALLBONDS™ warrants to the Customer/Property Owner that the aluminum composite panels as supplied are free from any defects which would cause the panels to delaminate within a twenty (20) year period from the time of shipment.

ALLBONDS™ agrees to repair or replace, at its sole cost and option, any aluminum composite panels that experience delamination during the warranty period as a result of any material and/or manufacturing defects.

This warranty is not applicable to defects or panel deterioration from causes and/or occurrences beyond the control of ALLBONDS™ and otherwise unrelated to the manufacturing process, including but not limited to the following:

- Faulty or improper fabrication, care, and installation
- Exposure to a corrosive or aggressive atmosphere
- Building settlement or structural failure
- Unreasonable use, misuse, abuse, negligence, vandalism, accidental damage, or acts of God such as fires, floods, earthquakes, lightning, et al.;
- Panels that are modified or altered in a manner not authorized by ALLBONDS™ in writing
- Labor charges for dismantling or reinstalling a repaired or replaced panel



COATING WARRANTY

ALLBONDS™ warrants to the Customer/Property Owner that the architectural coating applied to the aluminum composite material will not deteriorate and/or fail as a direct result of manufacturing defects for a period of up to twenty (20) years from the time of shipment. Thirty years warranty is also available.

Coating deterioration/failure is defined as follows:

Peeling, checking, or cracking (except for slight crazing or cracking as may occur on normal roll-forming or brake bending which is accepted in the industry as standard);

Chalk in excess of a numerical rating of 6 as measured in accordance with standard procedures as specified in ASTM D-4214 (Method D-659); Fade or a color change in excess of 5 color difference units when measured according to ASTM D-2244 on exposed paint surfaces which have been cleaned of external deposits and chalk.

This coating warranty will not cover the following:

- Corrosive and/or aggressive atmospheric conditions such as chemical fumes, salt, or other corrosive elements
- Damage to the coating as a result of moisture and/or other contamination due to improper storage during shipment, during fabrication, or at the job site prior to installation
- Damage to the coating caused by improper handling, shipping, processing, or installation and other non-manufacturing occurrences
- Damage to the coating as a result of ponding or standing water
- Unreasonable use, misuse, abuse, negligence, vandalism, or accidental damage, or acts of God such as fires, floods, earthquakes, lightning, et al.
- Panels that are modified or altered in a manner not authorized by ALLBONDS™ in writing
- Labor charges for dismantling or reinstalling a repaired or replaced panel

It is recognized that fading or color change may not be uniform if the coated surfaces are not equally exposed to the sun and the elements, and therefore non-uniform fading in this situation is excluded from the warranty.

In order to qualify for warranty coverage all claims must be submitted within thirty (30) days from the date the damage or defect is discovered – or could have been discovered – but in no event may claims be submitted more than thirty (30) days following the expiration of the original warranty period.

ALLBONDS™ shall be given a reasonable period of time to inspect the product. If after the inspection, ALLBONDS™ determines that any defect is covered under the warranty, ALLBONDS™ at its option shall refinish, repair, or replace the defective product(s) at no cost to the Customer/Property Owner. The warranty period applicable to any refinished, repaired, or replaced product(s) shall be for the remaining un-expired portion of the original warranty period(s).

THIS LIMITED WARRANTY IS IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE, AND OF ANY OTHER OBLIGATIONS OR LIABILITY ON ALLBONDS™ PARTY. THIS LIMITED WARRANTY DOES NOT COVER NON-DEFECT DAMAGE. IN NO EVENT SHALL ALLBONDS™ BE LIABLE FOR INCIDENTAL, PUNITIVE, LOST PROFITS, SPECIAL OR CONSEQUENTIAL DAMAGES, DIRECT OR INDIRECT, OR FOR ANY BREACH OF ANY EXPRESS OR IMPLIED WARRANTIES IN CONNECTION WITH THE PRODUCT. AND, IN NO EVENT SHALL ALLBONDS™ LIABILITY FOR BREACH OF WARRANTY, BREACH OF CONTRACT, NEGLIGENCE, OR STRICT LIABILITY EXCEED THE COST OF THE PRODUCT. THIS WARRANTY IS THE ONLY EXPRESS WARRANTY EXTENDED BY ALLBONDS™ IN CONNECTION WITH THE PRODUCT, AND IT EXCLUDES ALL OTHER WARRANTIES, REPRESENTATIONS, OR GUARANTEES, EXPRESS OR IMPLIED, WRITTEN OR ORAL, BY OPERATION OF LAW OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
